EXECUTION VERSION

RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS RELEASE OF TRADEMARK SECURITY AGREEMENT (this “Release”) is made as of December 6, 2011 (the “Effective Date”) by Bank of America, N.A., as administrative agent (in such capacity, the “Administrative Agent”) for the benefit of FleetPride Corporation, a Delaware corporation (the “Borrower”), FleetPride, Inc., an Alabama corporation (“FleetPride”) and Parts Distributing Company, Ltd., a Texas limited liability partnership (“Parts Distributing” and together with FleetPride, the “Grantors”).

WHEREAS, pursuant to the terms and conditions of that certain Guarantee and Collateral Agreement, dated as of June 6, 2006, between the Borrower, the Grantors, certain other subsidiaries of the Borrower party thereto and the Administrative Agent and the Trademark Security Agreement between the Grantors and the Administrative Agent dated as of June 6, 2006 (the “Trademark Security Agreement”), the Grantors pledged, assigned and granted to the Administrative Agent a continuing security interest in all of its right, title and interest in and to certain collateral including, without limitation, the trademark registrations and applications set forth on Schedule I to the Trademark Security Agreement, along with the goodwill associated therewith (collectively, the “Trademarks”);

WHEREAS, the Trademark Security Agreement was recorded with the Trademark Division of the U.S. Patent & Trademark Office on June 9, 2006 at Reel 3324 and Frame 0695;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby terminates the Trademark Security Agreement, and hereby terminates, cancels and releases any and all security interests it has against the Trademarks listed under Schedule 1 attached hereto.


If and to the extent the Administrative Agent has acquired any right, title or interest to any of the Trademarks, it hereby re-assigns and re-transfers such rights, title or interest to their respective Grantors.

The Administrative Agent shall take all further actions, and provide to the Grantors and their successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantors to more fully and effectively effectuate the purposes of this Release, all at the expense of the Grantors.

This Release shall be governed by and construed in accordance with, the laws of the State of New York.
