SHORT FORM TRADEMARK LICENSE

For Ten U.S. Dollars (US\$10.00) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Licensor hereby licenses to Miramax a non-exclusive, royalty-free transferable (including, without limitation, sub-licensable), worldwide, fully paid-up license to use and exploit the Trademarks, and all of the goods and services covered thereby, set forth on Schedule A attached hereto and incorporated herein by this reference (the "Trademarks") in any manner in connection with its business until the earlier to occur of: (a) twenty-five (25) years following the Effective Date, and (b) Miramax's termination as "Manager" under and in accordance with the terms of the Management Agreement entered into between Miramax and Licensor as of the Effective Date. Miramax agrees that the Trademarks shall be used only in accordance with whatever standards of conduct and quality in relation to the use of the Trademarks as the Licensor may stipulate to Miramax from time to time.
