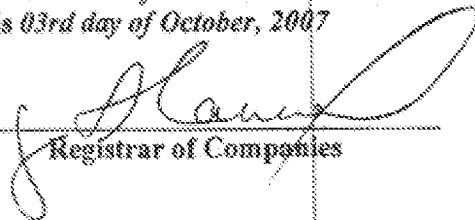

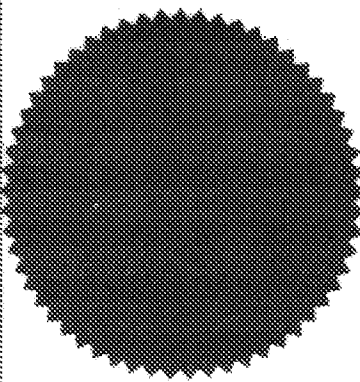

I, the undersigned, the sole member of

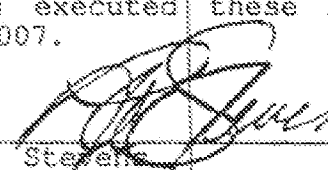

3. Section 1 of the Articles of Organization is hereby amended as follows:

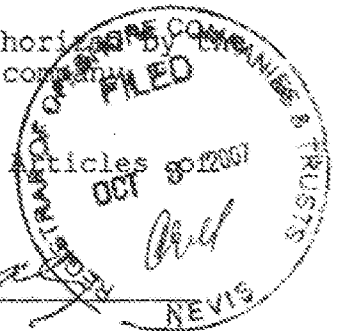
"The name of the company shall be **TELEMANIA, LLC.**"

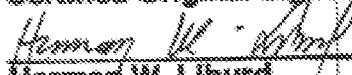

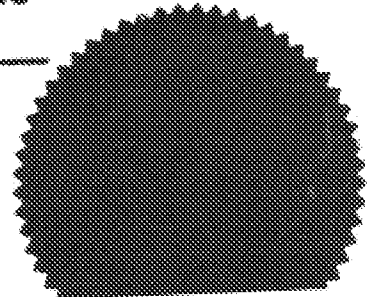
