

The Assignor makes no representations, warranties, conditions, covenants, guarantees or obligations of any kind in relation to the Trade-marks, including, without limitation, with respect to title and non-infringement of third-party intellectual property or other proprietary rights.

The Assignor hereby undertakes at any time upon reasonable request to execute such documents and take such further actions as may be necessary to evidence the assignment of the Trade-marks to the Assignee, and to enable the Assignee to obtain and maintain registrations for the Trade-marks, all without further consideration but at the sole expense of the Assignee.




