**RELEASE OF ASSIGNMENT FOR SECURITY IN TRADEMARKS**

**THIS RELEASE OF ASSIGNMENT FOR SECURITY IN TRADEMARKS** (this "Release") is made as of December 6, 2011 (the "Effective Date") by Fortress Credit Corp., a Delaware corporation, as agent for certain lenders (in such capacity, the "Agent") for the benefit of FleetPride, Inc., an Alabama corporation, as successor to Parts Distributing Company, LTD (the "Grantor").

**WHEREAS**, pursuant to the terms and conditions of that certain Security Agreement, dated as of September 30, 2004, between the Grantor and the Agent, and the Assignment for Security Trademarks, dated as of September 30, 2004, between the Grantor and the Agent (the "Trademark Assignment"), the Grantor pledged, assigned and granted to the Agent a continuing security interest in all of its right, title and interest in and to certain collateral including, without limitation, the trademark registrations and applications set forth on Schedule 1A to the Trademark Assignment, along with the goodwill associated therewith (collectively, the "Trademarks");

**WHEREAS**, the Trademark Assignment was recorded with the Trademark Division of the U.S. Patent & Trademark Office on October 11, 2004 at Reel 2953 and Frame 0684;

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby terminates the Trademark Assignment, and hereby terminates, cancels and releases any and all security interests it has against the Trademarks listed under Schedule 1A attached hereto.

If and to the extent the Agent has acquired any right, title or interest to any of the Trademarks, it hereby re-assigns and re-transfers such rights, title or interest to the Grantor.

The Agent shall take all further actions, and provide to the Grantor and their successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantor to more fully and effectively effectuate the purposes of this Release, all at the expense of the Grantor.

This Release shall be governed by and construed in accordance with, the laws of the State of New York.
