RELEASE OF
GRANT OF SECURITY INTEREST
IN TRADEMARKS

WHEREAS, BROADSPIRE SERVICES, INC., a Delaware corporation (the "Pledgor"), with an office at 1601 Southwest 80th Terrace, Plantation, Florida 33324, is the owner of the trademarks and service marks listed on Schedule A attached hereto, which marks are registered or have pending applications in the United States Patent and Trademark Office (or the appropriate registry or filing office in the applicable country in which such marks are registered or applications are pending) as set forth on Schedule A attached hereto (all such trademarks, service marks, registrations and applications, collectively, the "Trademarks"); and

WHEREAS, in order to secure certain indebtedness, the Pledgor entered into a Security Agreement dated as of October 31, 2006 (as amended, modified, restated or supplemented from time to time, collectively the "Security Agreement"), in favor of SUNTRUST BANK, a Georgia banking corporation, as Administrative Agent, (the "Administrative Agent"), and pursuant thereto executed and delivered a Trademark Security Agreement as recorded in the United States Patent and Trademark Office on Reel 3420-Frames 0898-0907, recorded November 2, 2006 (the "Short-Form Security Agreement"), pursuant to which the Pledgor granted to the Administrative Agent, according to the terms of the Security Agreement, a security interest in all of its right, title and interest in and to the Trademarks;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent does hereby release and relinquish, and does hereby reassign to the Pledgor, without representation or warranty, all of the Administrative Agent's right, title and interest in and to the Trademarks listed on the attached Schedule A, and the use thereof, together with all proceeds and products thereof and the goodwill of the businesses symbolized by the Trademarks, and does hereby agree that the filing of the Short-Form Security Agreement in the United States Patent and Trademark Office as aforesaid may be removed of record.
