
DECLARATION

I, the undersigned, Patricia M. H. Sorensen, solemnly state and declare the following:

1. I am over the age of 18, am otherwise competent to testify and have personal knowledge of the facts attested herein. I am an attorney licensed to practise in the state of California. I am testifying based on my personal knowledge of each of the facts stated herein.
2. I was the Corporate Counsel of Starbase Corporation at the time Starbase Corporation acquired the stock of Premia Corporation on or about March 8, 2000.
3. Because of my functions and position in Starbase Corporation at that time, I was generally familiar with its business and I was also familiar with the circumstances and events surrounding the transaction between Starbase Corporation and Premia Corporation, having access to all documents and information relevant thereto and information regarding the trademark CODEWRIGHT, US Reg. #2,130,365.
4. On March 8, 2000 the stock of Premia Corporation was purchased by Starbase Corporation. Accordingly, Premia Corporation's stock, including all its intellectual property rights and assets, were transferred to Starbase Corporation. I am familiar with the contents of the Stock Purchase Agreement entered between Starbase Corporation and Premia Corporation dated March 8, 2000.

5. The US PTO records and website show that US Reg. #2,130,365 for the trademark CODEWRIGHT issued on January 20, 1998 in the name of Premia Corporation.
6. The trademark CODEWRIGHT, US Reg. #2,130,365 is specifically mentioned as part of the assets of Premia Corporation in the Stock Purchase Agreement between Starbase Corporation and Premia Corporation dated March 8, 2000. I can confirm that this trademark registration was part of the assets of Premia Corporation, and was indeed transferred to Starbase Corporation.
7. On September 21, 2000 Premia Corporation was dissolved. Attached as Exhibit A to this Affidavit is a copy of the Oregon Business Registry showing the current status of Premia Corporation as inactive.
8. By operation of law US Reg. #2,130,365 became an asset of Starbase Corporation as the sole stock holder of Premia Corporation's stock when Premia Corporation dissolved.
9. Accordingly, by virtue of all the above mentioned facts, the ownership of US Reg. #2,130,365 transitioned from Premia Corporation to Starbase Corporation, which became the rightful owner of US Reg. #2,130,365.
10. I, the undersigned, being warned that willful false statements and the like are punishable by fine or imprisonment, or both, under 18 U.S.C. 1001, and that such willful false statements and the like may jeopardize the validity of the application or document or any registration resulting therefrom, declare under penalty or perjury that all statements made of my own knowledge are true; and all statements made on information and belief are believed to be true.
