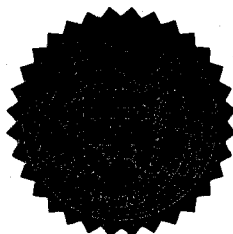

CERTIFICATE OF OWNERSHIP AND MERGER

MERGING

TELECOMMUNICATIONS REPORTS INTERNATIONAL, INC.

INTO

CCH INCORPORATED

CCH Incorporated, a corporation organized and existing under the laws of Delaware,

DOES HEREBY CERTIFY:

FIRST: That this corporation was incorporated on the 30th day of November 1988, pursuant to the General Corporation Law of the State of Delaware.

SECOND: That this corporation owns all of the outstanding shares (of each class) of the stock of Telecommunications Reports International, Inc. ("TRI") a corporation incorporated on the 12th day of May 1999, pursuant to the General Corporation Law of the State of Delaware.

THIRD: That this corporation, by the following resolutions of its Board of Directors, duly adopted by the unanimous written consent of its members, filed with the minutes of the Board on the 17th day of July 2002, determined to merge into itself said TRI:

RESOLVED that the Corporation merge, and it hereby does merge into itself Telecommunications Reports International, Inc. and assumes all of its obligations;

and

FURTHER RESOLVED, that the merger shall be effective as of August 31, 2002;

and

FURTHER RESOLVED, that the proper officer of this corporation be and he or she is hereby directed to make and execute a Certificate of Ownership and Merger setting forth a copy of the resolutions to merge said TRI and assume its liabilities and obligations, and the date of adoption thereof, and to cause the same to be filed with the Secretary of State and to do all acts and things whatsoever, whether within or without the State of Delaware, which may be in anywise necessary or proper to effect said merger,

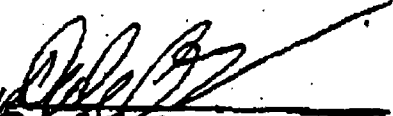
