**CERTIFICATE OF AMENDMENT  
TO THE  
AMENDED AND RESTATED CERTIFICATE OF INCORPORATION  
OF  
RUSH TRACKING ACQUISITION CORPORATION,  
a Delaware corporation**

Pursuant to the Delaware Corporation Law, the Certificate of Incorporation of **Rush Tracking Acquisition Corporation**, a Delaware corporation (the "Corporation"), is hereby amended as follows:

**FIRST:** The Amended and Restated Certificate of Incorporation of the Corporation is hereby amended by deleting Article One in its entirety and inserting the following in lieu thereof:
