**NUNC PRO TUNC ASSIGNMENT
OF TRADEMARKS**

WHEREAS, B2X Corporation, a corporation duly organized and existing under the laws of the State of Delaware and having offices at 10 Exchange Place, 25th Floor, Jersey City, New Jersey 07302, (hereinafter referred to as "ASSIGNOR"), as of July 8, 2009, was the exclusive and record owner of all right, title and interest in and to the trademarks identified in Schedule A attached hereto, and the applications and registrations therefore identified on Schedule A attached hereto, any common law rights relating to any of the foregoing, together with all associated goodwill represented by any of the foregoing, and the right to sue and recover for, and the right to damages, profits and penalties due or accrued, arising out of or in connection with, any and all infringements or dilution of or damage or injury to any and all of the foregoing (all of the foregoing individually and/or collectively referred to as "Trademark Rights");

WHEREAS, The TJX Companies, Inc., a corporation duly organized and existing under the laws of the State of Delaware and having a principal office at 770 Cochituate Road, Framingham, Massachusetts 01701 (hereinafter referred to as "ASSIGNEE"), and ASSIGNOR entered into an Assignment Agreement dated October 29, 2008 pursuant to which ASSIGNEE acquired and purchased from ASSIGNOR certain trademarks and related rights (hereinafter referred to as the "Prior Agreement");

WHEREAS, subsequent to the execution of the Prior Agreement, ASSIGNOR and ASSIGNEE agreed that it was each of their intentions that the Trademark Rights were to have been included within those certain trademarks and related rights acquired and purchased pursuant to the Prior Agreement, and therefore ASSIGNEE acquired and purchased from ASSIGNOR the Trademark Rights, and associated goodwill of ASSIGNOR, effective July 9, 2009; and

WHEREAS, ASSIGNOR and ASSIGNEE desire to confirm and perfect the sale and assignment of the Trademark Rights, and associated goodwill, effective July 9, 2009.

NOW THEREFORE, for good and valuable consideration (including the consideration paid for under the Prior Agreement), the receipt and sufficiency of which is hereby acknowledged, ASSIGNOR hereby acknowledges and confirms that effective July 9, 2009, ASSIGNOR sold, transferred, and assigned to ASSIGNEE any and all of the Trademark Rights, and associated goodwill of ASSIGNOR, as fully and entirely as the same would have been held by ASSIGNOR had this assignment not been made.

ASSIGNOR hereby represents and warrants that it owned all right, title and interest in and to the Trademark Rights as of July 8, 2009, that it had the full power and authority to convey the rights, title, and interests sold, transferred, and assigned to ASSIGNEE, that it has not executed and will not execute any agreement in conflict herewith, and that it will execute any and all other instruments which may be necessary to perfect and evidence ASSIGNEE's ownership of the property and rights herein conveyed.

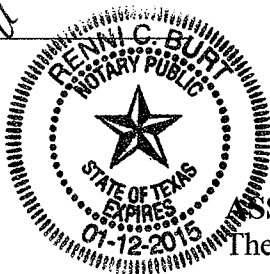

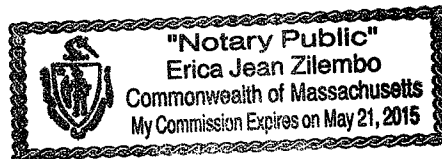
