**PARTIAL RELEASE OF SECURITY
INTEREST IN INTELLECTUAL PROPERTY**

This PARTIAL RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this "Release"), dated as of December 12, 2011 (the "Effective Date"), is made by Deutsche Bank Trust Company Americas (the "Collateral Agent"), in its capacity as collateral agent for the lending institutions under the Credit Agreement, in favor of OMNOVA Solutions Inc. (the "Grantor").

WHEREAS, the Collateral Agent, the Grantor and certain other persons are parties to that certain Credit Agreement, dated as of May 22, 2007, as amended and restated on December 9, 2010 (as amended or otherwise modified to date, the "Credit Agreement"), and that certain Security Agreement, dated as of May 22, 2007 and amended and restated as of December 9, 2010 (as amended or otherwise modified to date, the "Security Agreement");

WHEREAS, pursuant to the Security Agreement, the Grantor executed a Grant of Security Interests in Certain Patents and Trademarks, dated as of May 22, 2007 (the "IP Security Agreement"), in favor of the Collateral Agent to evidence the security interest granted by the Grantor to the Collateral Agent in and to the Grantor's patents and trademarks, which IP Security Agreement was filed and recorded with the Trademarks Division of the United States Patent and Trademark Office at Reel/Frame 3588/0344; and

WHEREAS, in connection with the proposed sale of certain assets of the Grantor, including the trademark registrations and trademark applications set forth on Schedule A attached hereto (the "Released Trademarks"), pursuant to the Purchase Agreement, dated as of December 12, 2011, between the Grantor and J. Josephson Inc., the Grantor has requested the Collateral Agent to execute this Release pursuant to the applicable terms and conditions set forth in the Credit Agreement, and the Collateral Agent has agreed to execute this Release in reliance of the Grantor's certifications and representations regarding such proposed sale (the "Proposed Sale") as set forth the Confirmation of Partial Release of Collateral, dated as of even date herewith, between the Collateral Agent and the Grantor (the "Confirmation").

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Collateral Agent hereby agrees as follows:

1. Partial Release. In reliance on the certifications and representations of the Grantor regarding the Proposed Sale as set forth in the Confirmation, the Collateral Agent hereby, as of the Effective Date, without any representations or warranties of any kind, on behalf of itself and the lending parties under the Credit Agreement, releases the security interest arising under the Security Agreement and the IP Security Agreement in and to the Released Trademarks. For the avoidance of any doubt, the foregoing release applies only and solely with respect to the Released Trademarks, and shall not extend to or relate to any other Collateral (as defined in the Credit Agreement). The Credit Agreement, the Security Agreement and the IP Security Agreement with respect to such other Collateral shall remain in full force and in effect.


2. Recordation with the United States Patent and Trademark Office. The Collateral Agent hereby authorizes the Grantor (or such Person as the Grantor may designate) to file and records this Release with the United States Patent and Trademark Office.

3. Governing Law. Except to the extent that federal law preempts state law with respect to the matters covered hereby, this Release shall be governed by and construed in accordance with the laws of the State of New York without giving effect to the principles of conflicts of laws thereof.


