**RELEASE OF TRADEMARKS AND LICENSES
SECURITY AGREEMENT**

THIS RELEASE OF TRADEMARKS AND LICENSES SECURITY AGREEMENT, dated as of December 13, 2011, is made by KEYBANK NATIONAL ASSOCIATION, a national banking association. Capitalized terms used but not defined herein will have the meaning given to them in the Credit Agreement.

WHEREAS, AcuSport Corporation, an Ohio corporation ("Grantor"), entered into that certain Credit and Security Agreement dated as of September 30, 2003 (as from time to time amended, modified or supplemented, the "Credit Agreement"), among the Grantor as borrower (the "Borrower"), the Lenders which are signatories thereto (the "Lenders"), KeyBank National Association, as Administrative Agent and letter of credit issuer (the "LC Issuer"), pursuant to which, upon the satisfaction by the Grantor of certain terms and conditions contained therein, the Lenders and the LC Issuer (collectively the "Loan Parties") will make certain advances and other financial accommodations available to the Grantor;

WHEREAS, Pursuant to the Credit Agreement, Grantor and Administrative Agent are parties to that certain Trademarks and Licenses Security Agreement, dated as of September 30, 2003 (the "Agreement"), which was recorded with the United States Patent and Trademark Office on December 3, 2003, in its records at Reel 2882, Frame 0359, in which Grantor agreed to grant the Administrative Agent a security interest in all of its right, title and interest in and to the trademarks described in Exhibit A, and the goodwill symbolized by such trademarks (the "Goodwill") and a security interest in and to all trademarks and Goodwill acquired by Grantor after the date thereof; and (ii) a security interest in and to any license agreements in which Grantor is or becomes licensed to use know-how, a patent, copyright, mask work, semi-conductor chip product, trademark, trade secret or other proprietary right; all as collateral security for the Obligations (as defined in the Credit Agreement); and

WHEREAS, Administrative Agent, on behalf of the Loan Parties, desires to release its rights and security interest in the trademarks and licenses described in Exhibit A and Exhibit B.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Administrative Agent, on behalf of the Loan Parties, hereby fully and finally releases and terminates (i) its security interest and other rights in, to and under the trademarks and licenses described in Exhibit A and Exhibit B; and (ii) any and all other rights it may have under the Agreement.
