## Release of Lien on Trademarks

**THIS RELEASE OF LIEN ON TRADEMARKS** is entered into as of November 1, 2011, by and between SONIC SOLUTIONS LLC, a California limited liability company (the “**Pledgor**”) and JPMORGAN CHASE BANK, N.A., in its capacity as collateral agent pursuant to the Credit Agreement (in such capacity, the “**Collateral Agent**”).

**WHEREAS**, the Pledgor entered into that certain Trademark Security Agreement dated as of March 25, 2011 (the “**Agreement**”) in favor of the Collateral Agent to evidence its grant of a security interest in the trademarks set forth on Schedule A hereto;


**WHEREAS**, the Agreement was recorded with the United States Patent and Trademark Office on March 25, 2011 on reel 004506 frame 0130;
