SHORT FORM TRADEMARK AND PATENT SECURITY AGREEMENT

TRADEMARK AND PATENT SECURITY AGREEMENT (this "IP Security Agreement"), dated December 14, 2011, is executed by each of the signatories identified on the signature pages hereto as "Grantors" (the "Grantors"), in favor of GOLDMAN SACHS CREDIT PARTNERS L.P., ("GSCP"), as Collateral Agent (in such capacity, the "Collateral Agent") for the Secured Parties (as defined in the Credit Agreement referred to below).

WITNESSETH:

WHEREAS, pursuant to the Second Amendment and Restatement Agreement dated as of October 7, 2011 (as amended, supplemented or otherwise modified from time to time, the "Credit Agreement"), among MEDIMEDIA USA, INC. (the "Borrower"), STAYWELL CUSTOM COMMUNICATIONS, LLC, KRAMES STAYWELL, LLC (f/k/a THE STAYWELL COMPANY), THREE V HEALTH, LLC (f/k/a THREE V HEALTH, INC.) (as Borrowers), CERTAIN SUBSIDIARIES OF MEDIMEDIA USA, INC., and MMUSA ACQUISITION CORP. ("Holdings"), the Lenders parties thereto (the "Lenders"), GOLDMAN SACHS CREDIT PARTNERS L.P. ("GSCP"), as Administrative Agent (in such capacity, "Administrative Agent") and as Collateral Agent (in such capacity, "Collateral Agent"), to the Amended and Restated Credit and Guaranty Agreement dated as of October 5, 2006, as amended and restated as of April 11, 2007 (as in effect immediately prior to the Second Restatement Effective Date (as defined below), the "First Restated Credit Agreement"), among the Borrower, certain of its subsidiaries, Holdings, the lenders from time to time party thereto (the "Existing Lenders"), the Administrative Agent and the Collateral Agent the Lenders have severally agreed to make extensions of credit to the Borrower upon the terms and subject to the conditions set forth in the Credit Agreement;

WHEREAS, it is a condition precedent to the obligation of the Lenders to make their respective extensions of credit to the Borrower under the Credit Agreement that the Grantors shall have executed and delivered to the Administrative Agent, a Pledge and Security Agreement, in favor of the Collateral Agent (the "Security Agreement") to guarantee the Obligations; and

WHEREAS, the Grantors are required to execute and deliver this IP Security Agreement pursuant to the Security Agreement;

NOW, THEREFORE, in consideration of the premises and to induce the Administrative Agent and the Lenders to enter into the Credit Agreement and to induce the Lenders to make their respective extensions of credit to the Borrower thereunder, each Grantor hereby agrees with the Collateral Agent, for the benefit of the Secured Parties, as follows:

Section 1. Defined Terms

Unless otherwise defined herein, terms used herein have the meanings given to them in the Security Agreement or Credit Agreement, as applicable.

Section 2. Grant of Security Interest in Trademark Collateral

Each Grantor hereby grants to the Collateral Agent, for the benefit of the Secured Parties, a security interest in all of the following property (other than Excluded Assets) now owned or at any time hereafter acquired by such Grantor or in which such Grantor now has or at any time in the future may acquire any right, title or interest (collectively, the "Trademark Collateral"), as collateral security for the prompt and complete payment and performance when due (whether at the stated maturity, by acceleration or otherwise) of the Obligations (as defined in the Security Agreement) of such Grantor:

- (a) all of its Trademarks included in the Collateral, including, without limitation, those referred to on Schedule 1 hereto;
- (b) all renewals and extensions of the foregoing;
- (c) all goodwill of the business connected with the use of each such Trademark; and
- (d) to the extent not otherwise included, all Proceeds of any and all of the foregoing

Section 3. Grant of Security Interest in Patent Collateral

Each Grantor hereby grants to the Collateral Agent, for the benefit of the Secured Parties, a security interest in all of the following property (other than Excluded Assets) now owned or at any time hereafter acquired by such Grantor or in which such Grantor now has or at any time in the future may acquire any right, title or interest (collectively, the "Patent Collateral"), as collateral security for the prompt and complete payment and performance when due (whether at the stated maturity, by acceleration or otherwise) of the Obligations (as defined in the Security Agreement) of such Grantor:

- (a) all of its Patents included in the Collateral, including, without limitation, those referred to on Schedule 2 hereto together with any reissues, continuations, divisions, renewals, modifications, substitutions or extensions thereof and the inventions disclosed or claimed therein, including the right to make, use and/or sell the inventions disclosed or claimed therein;
- (b) any Patent Licenses;
- (c) any products and proceeds of the foregoing, including, without limitation, any claim by Debtor against third parties for past, present, or future infringement or breach of any Patent or Patent License, including, without limitation, any Patent or Patent License referred to in Schedule 2 hereto.

Section 4. Security Agreement

The security interest granted pursuant to this IP Security Agreement is granted in conjunction with the security interest granted to the Collateral Agent pursuant to the Security Agreement and each Grantor hereby acknowledges and affirms that the rights and remedies of the Collateral Agent with respect to the security interest in the Trademark Collateral and Patent Collateral

made and granted hereby are more fully set forth in the Security Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein. In the event of a conflict between the Security Agreement and this IP Security Agreement, the terms of the Security Agreement shall control.

Section 5. Grantor Remains Liable

Each Grantor hereby agrees that, anything herein to the contrary notwithstanding, such Grantor shall remain liable and assume full and complete responsibility for the prosecution, defense, enforcement or any other necessary or desirable actions in connection with the Trademark Collateral and Patent Collateral.

Section 6. Counterparts

This IP Security Agreement may be executed by one or more of the parties hereto in any number of separate counterparts (including by telecopy), and all of said counterparts taken together shall be deemed to constitute one and the same instrument.

Section 7. Governing Law

This IP Security Agreement and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the law of the State of New York.






