TRADEMARK RELEASE AND REASSIGNMENT

THIS TRADEMARK RELEASE AND REASSIGNMENT (this "Release") is made as of December 15, 2011 by GENERAL ELECTRIC CAPITAL CORPORATION, a Delaware corporation, acting in its capacity as the successor Agent (in such capacity, the "Agent") for the benefit of itself and the "Secured Parties" under the Credit Agreement (as such terms are hereinafter defined).

WITNESSETH:

WHEREAS, Agent and FRANK GATES SERVICE COMPANY, an Ohio corporation ("FG Service"), THE FRANK GATES COMPANIES, INC., an Ohio corporation ("FGC"), NATIONAL EMPLOYER NETWORK ALLIANCE, INC., an Ohio corporation ("National Employer"), VISUAL RISK SOLUTIONS, INC., an Ohio corporation ("Visual Risk"; FG Service, FGC, National Employer and Visual Risk, collectively, the "Grantors"), are parties to that certain Amended and Restated Trademark Security Agreement dated as of May 20, 2011 (the "**Trademark Security Agreement**"; capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed to such terms in the Second Amended and Restated Credit Agreement (as such term is defined in the Trademark Security Agreement)), pursuant to which Grantor granted a security interest to Agent in the Trademarks Collateral (as defined in the Trademark Security Agreement) as security for certain obligations owing by Grantor to Agent, including the Trademark Collateral set forth on Schedule 1 annexed hereto; and

WHEREAS, the Security Agreement was recorded by the Trademark Division of the United States Patent and Trademark Office on May 20, 2011, at Reel 4545, Frame 0434; and

WHEREAS, Grantor has requested that Agent release its security interest in and Lien on all of Agent's right, title and interest in, to and under the Trademark Collateral set forth on Schedule 1 annexed hereto.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:


