THIS TRADEMARK RELEASE AND REASSIGNMENT (this "**Release**") is made as of December 15, 2011 by GENERAL ELECTRIC CAPITAL CORPORATION (successor-in-interest to Merrill Lynch Capital, a division of Merrill Lynch Business Financial Services Inc.), in its capacity as Administrative Agent for the Lenders party to the Credit Agreement (defined below) ("**Grantee**"):

WHEREAS, Grantor has requested that Administrative Agent release its security interest in and Lien on all of Administrative Agent's right, title and interest in, to and under the Trademark Collateral set forth on Schedule 1 annexed hereto.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:


1. Administrative Agent hereby releases its security interest in and Lien on all of Administrative Agent's right, title and interest in the Trademark Collateral, including the Trademarks set forth on Schedule 1 annexed hereto.
