Assignor shall execute and deliver to Assignee all such further instruments, assignments, assurances and other documents as Assignee may reasonably request or as may be necessary to more fully assign, transfer, convey and deliver to and do any such act to protect, secure and vest in Assignee all of such Assignor's rights, title and interests therein.

3. Assignor makes no warranty or other representation that the Trademarks or the associated registrations are valid or subsisting.
