TRADEMARK RELEASE AND REASSIGNMENT

THIS TRADEMARK RELEASE AND REASSIGNMENT (this “**Release**”) is made as of December 15, 2011 by General Electric Capital Corporation (successor-in-interest to Merrill Lynch Capital, a division of Merrill Lynch Business Financial Services Inc.), in its capacity as Administrative Agent for the Lenders party to the Credit Agreement (defined below) (“**Grantee**”):

W I T N E S S E T H:

WHEREAS, Grantee and The Frank Gates Service Company (formerly known as Attenta, Inc.), a Delaware corporation (“**Grantor**”), are parties to that certain Trademark Security Agreement dated as of March 2, 2007 and that certain First Amendment to Trademark Security Agreement dated as of August 18, 2008 (“**First Amendment**”, together with the Trademark Security Agreement, collectively the “**Security Agreement**”; capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed to such terms in the Credit Agreement (as such term is defined in the Security Agreement)), pursuant to which Grantor granted a security interest to Administrative Agent in the Trademark Collateral (as defined in the Security Agreement) as security for certain obligations owing by Grantor to Administrative Agent, including the Trademark Collateral set forth on Schedule 1 hereto; and

WHEREAS, the Trademark Security Agreement was recorded by the Trademark Division of the United States Patent and Trademark Office on March 12, 2007, at Reel 3497, Frame 0758 and the First Amendment was recorded by the Trademark Division of the United States Patent and Trademark Office on August 18, 2008, at Reel 3837, Frame 0357; and

WHEREAS, Grantor has requested that Administrative Agent release its security interest in and Lien on all of Administrative Agent’s right, title and interest in, to and under the Trademark Collateral set forth on Schedule 1 hereto.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:


