CONFIRMATORY ASSIGNMENT

THIS CONFIRMATORY ASSIGNMENT ("Assignment") is made as of the 21st day of October, 2011 (the "Effective Date") by Sanjiv Lakhanpal ("Lakhanpal") in favor of CVR Management, LLC, a Delaware limited liability company ("CVR").

WHEREAS, pursuant to the Amended and Restated Intellectual Property Assignment Agreement dated as of October 21, 2011 (the "Agreement"), CVR acquired from Lakhanpal the intellectual property set forth on Exhibit A including all common law rights therein, goodwill associated therewith, applications and registrations thereof, and renewals thereof (the "Assigned IP");

WHEREAS, pursuant to the Agreement, CVR also acquired from Lakhanpal all causes of action for infringement of the Assigned IP that may have arisen prior to, or after, the Agreement, all income, royalties, damages and payments now or hereafter due or payable with respect to the Assigned IP, all claims for damages by reason of past and future infringement of the Assigned IP, and the right to sue and collect damages for such infringement, to be held and enjoyed by CVR for its own use and benefit and for its successors and assigns;

WHEREAS, Lakhanpal desires to confirm having assigned all of his right, title, and interest in and to the Assigned IP to CVR.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Lakhanpal hereby confirms having assigned, transferred and set over to CVR, effective as of October 21, 2011, his entire right, title and interest in and to the Assigned IP, together with (i) the associated goodwill; (ii) all causes of action for infringement of the Assigned IP that may have arisen prior to, or after, the Agreement; (iii) all income, royalties, damages and payments now or hereafter due or payable with respect to the Assigned IP; (iv) all claims for damages by reason of past and future infringement of the Assigned IP; and (v) the right to sue and collect damages for such infringement, the same to be held and enjoyed by CVR and its successors and assigns.


