## ASSIGNMENT AND RELEASE OF TRADEMARK SECURITY INTEREST

This ASSIGNMENT AND RELEASE OF TRADEMARK SECURITY INTEREST (this “Release”) is dated as of the date set forth above. Reference is hereby made to that certain TRADEMARK SECURITY AGREEMENT (the “Trademark Security Agreement”; capitalized terms used but not defined herein shall have the meanings given to them in the Trademark Security Agreement), dated as of December 19, 2007 by Duhn Oil Tool, Inc. (“Assignor”), in favor of Freeport Financial LLC, as administrative agent (the “Administrative Agent”), recorded with the United States Patent and Trademark Office on February 1, 2008, at Reel/Frame No. 3711/0394.

For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby notifies, acknowledges and agrees with Assignor that (i) the lien on and security interest in the Trademarks and Trademark Licenses pledged and granted by such Assignor pursuant to the Trademark Security Agreement to the Administrative Agent for the benefit of the Lenders and the Administrative Agent, including, without limitation, the lien on and security interest in the trademarks listed on the attached Schedule A is terminated, released and discharged fully, (ii) the Administrative Agent hereby releases and forever discharges fully all of its right, title and interest in, to and under, and of any kind or nature in the Trademark Collateral granted, assigned or conveyed pursuant to the Trademark Security Agreement, and (iii) any right, title or interest of the Administrative Agent in, to and under the Trademark Collateral shall hereby cease and become void.

The Administrative Agent hereby authorizes and requests the Commissioner of Patents and Trademarks and any other applicable government officer to record this Release. The Administrative Agent hereby agrees to execute, acknowledge and deliver, upon the request of Assignor, such additional documents as are reasonably necessary to register and otherwise give full effect to, and to perfect the rights of Assignor under, this release in and to the Trademarks and Trademark Licenses worldwide, including all documents reasonably necessary to register in the name of Assignor the assignment of the Trademarks and Trademark Licenses with the United States Patent and Trademark Office and, with respect to any equivalent foreign rights, with any other appropriate foreign or international office or registrar.
