**RECITALS:**

- A. GreenField Ethanol Inc. (the "**Obligor**"), a corporation continued under the *Canada Business Corporations Act*, is the beneficial owner of (i) the trade marks set forth in Exhibit A, the registrations and applications for the trade marks identified therein and the underlying goodwill of said trade marks (collectively, the "**Trade Marks**"), and (ii) the patents set forth in Exhibit A, the applications for the patents identified therein and the underlying goodwill of said patents (collectively, the "**Patents**" and, together with the Trade Marks, the "**Intellectual Property**").
- B. The Obligor has entered into a trust deed dated as of 27 September 1996 between the Obligor and Montreal Trust Company of Canada, as supplemented by a supplemental trust deed dated as of 9 December 2002, by which Computershare Trust Company of Canada (the "**Trustee**") was appointed as successor trustee to Montreal Trust Company of Canada and by a second supplemental trust deed dated as of 31 January, 2006, and as further amended, supplemented, restated or replaced from time to time ("**Trust Deed**").
- C. Under the Trust Deed the Obligor granted to the Trustee a security interest in certain property, including the Intellectual Property, as security for the obligations described therein.

**NOW THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are acknowledged and in accordance with the terms and obligations set forth in the Trust Deed, the Obligor confirms the grant to the Trustee under the Trust Deed an interest in and to the Intellectual Property.
