Assignor hereby authorizes and requests the United States Commissioner of Patents and Trademarks, and authorized officials in countries outside of the United States of America, to grant and maintain trademark registrations to Assignee as the owner of the entire right, title and interest in and to the Trademarks, the Trademark Applications, the Trademark Registrations and the Goodwill, for the sole use and enjoyment of Assignee, its successors and assigns.


