RELEASE OF TRADEMARK SECURITY AGREEMENT

This Release of Trademark Security Agreement (the "Release"), dated and effective as of December 15, 2011 (the "Effective Date"), is made by Wells Fargo Bank, National Association (the "Secured Party"), acting through its Wells Fargo Business Credit operating division.

RECITALS

WHEREAS, the Secured Party is a party to the Trademark Security Agreement, dated as of April 30, 2006 ("Security Agreement"), by and between Secured Party and Laidlaw Acquisition Company LLC, as "Debtor."

WHEREAS, in connection the Security Agreement, the Debtor granted to the Secured Party security interests in the Trademarks as defined in the Security Agreement, including without limitation the Trademarks listed on Exhibit A to this Release;

WHEREAS, on January 16, 2008, the Secured Party recorded the Security Agreement with the United States Patent and Trademark Office ("USPTO"), evidencing its security interest in the Trademarks;

WHEREAS, Debtor subsequently: (i) changed its name to Laidlaw Company LLC; and (ii) assigned the Trademarks to ADCO Cleaning Products LLC, a Delaware corporation with place of business at 900 West Main, Sedalia, Missouri 65302-0999; and

WHEREAS, Secured Party desires to release its security interests in the Trademarks pursuant to this Release.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Secured Party hereby: (a) releases all of its security interest in the Trademarks; (b) authorizes the recordation of this Release with the USPTO and any other authority or office as may be necessary to effectuate this Release; and (c) agrees to cooperate with the Debtor and to execute, acknowledge and deliver such further releases, termination statements, assignments and other assurances pursuant to this Release, as may be reasonably requested by the Debtor in order to effectuate the complete release of the Secured Party's security interests in the Trademarks.
