UNDER SECTION 805 OF THE BUSINESS CORPORATION LAW

FIRST: The name of the corporation is TD Waterhouse Investor Services, Inc. The name under which the corporation was formed is Waterhouse Securities, Inc.

SECOND: The date of its incorporation is September 29, 1978.

THIRD: TD Waterhouse Investor Services, Inc. is a corporation organized and existing under and by virtue of the Business Corporation Law of the State of New York.


