**RELEASE OF SECURITY INTEREST  
IN INTELLECTUAL PROPERTY RIGHTS**

**THIS RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY** (this "Release") is made as of 7/24/2005 ("Effective Date") by and between Bank of America (the legal successor to Fleet Bank, N.A., a/k/a Fleet National Bank) ("Administrative Agent") and Physician Computer Network, Inc., Versyss Incorporated, Wismer\* Martin, Inc., Integrated Health Systems, Inc., PCN HP Venture Corp., PCN Services Corp. and V Holding Corp. (the foregoing, collectively the "Borrower"). Capitalized terms not defined herein shall have the meanings ascribed to such terms in the Credit Agreement or the Guarantee and Collateral Agreement, as applicable.

**WHEREAS**, Borrower and Administrative Agent entered into that certain Credit Agreement dated September 10, 1997 (together with all amendments and modifications, if any, from time to time thereafter made) (the "Credit Agreement");

**WHEREAS**, pursuant to the Credit Agreement, Borrower and Administrative Agent entered into that certain Guarantee and Collateral Agreement dated September 10, 1997 (together with all amendments and modifications, if any, from time to time thereafter made) (the "Guarantee and Collateral Agreement");

**WHEREAS**, pursuant to the Guarantee and Collateral Agreement, Borrower pledged and granted to Administrative Agent, for the benefit of the Administrative Agent and the Lenders, a continuing security interest in and to all of Borrower's right, title and interest in and to all of the Collateral including, without limitation, the Intellectual Property set forth on Schedule attached hereto, together with the goodwill associated therewith, all proceeds thereof, and all causes of action relating thereof (collectively, the "IP Collateral");

**WHEREAS**, the Guarantee and Collateral Agreement was recorded with the United States Patent and Trademark Office on October 14, 1997, at Reel 1674, Frame 0820 and with the United States Copyright Office on \_\_\_\_, at Volume \_\_\_\_, Page \_\_\_\_; and

**WHEREAS**, Borrower has satisfied its Obligations under the Credit Agreement and the Guarantee and Collateral Agreement.

**NOW, THEREFORE**, effective as of the Effective Date, Administrative Agent, on its behalf and on behalf of the Lenders, hereby (i) reassigns and transfers to Borrower all right, title and interest in, to and under the IP Collateral, (ii) terminates, cancels and releases any and all security interests and rights of setoff it or Lenders' have in or against the IP Collateral, and (iii) terminates the Guarantee and Collateral Agreement.

Administrative Agent represents and warrants that: (i) it has the full power and authority to execute this Release on its behalf and on behalf of the Lenders; (ii) neither it nor the

Administrative Agent represents and warrants that: (i) it has the full power and authority to execute this Release on its behalf and on behalf of the Lenders; (ii) neither it nor the Lenders have assigned, transferred, restricted or otherwise encumbered any security interest they have against the IP Collateral.

Administrative Agent shall, at Borrower's expense, provide to Borrower, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all necessary documents or other instruments), reasonably requested by Borrower, in writing, to more fully and effectively effectuate the purposes of this Release.


This Release shall be binding upon Administrative Agent's legal representatives, assigns and successors. Administrative Agent hereby authorizes Borrower to make such filings with the United States Patent and Trademark Office as may be reasonably determined by Borrower to be required to record and evidence the release and termination of Administrative Agent's security interests in the Collateral evidenced hereby.

This Release shall be governed by and construed in accordance with the laws of the State of New York.
