This agreement is effective 2/10/2010, *nunc pro tunc*.

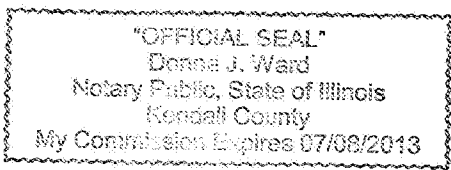
