**ASSIGNMENT OF TRADEMARK**

NOW, THEREFORE, for and in consideration of the sum of Seventy-Five Thousand Dollars U.S. (\$75,000.00), and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, said Assignor does hereby sell, transfer, convey and assign to said Assignee the entire right, title and interest in, to and under the SUBLIME trademark and any registrations and applications for registration thereof, including United States Trademark Registration No. 3,064,458 described in Schedule A (the "Trademark"), together with all goodwill associated with and symbolized by the Trademark, and all rights and privileges granted and secured thereby, including but not limited to the right to sue and recover for any past infringement, said rights to be held and enjoyed by said Assignee for its own use and benefit and for the use and benefit of its successors and assigns as fully and entirely as the same would have been held and enjoyed by said Assignor if this assignment had not been made. Assignor further agrees to execute any and all documents and do any such further acts that shall be required in order for Assignee to secure such rights.

AND, said Assignor hereby covenants that it has full right to convey the entire interest herein assigned, along with the goodwill and that portion of its business which has developed the services to which the Trademark pertains.
