DISCHARGE OF RECORDED SECURITY INTEREST IN TRADEMARKS

WHEREAS, by a Security Agreement dated December 11, 2009 (the "Security Agreement") Vantage Pointe Apparel & Promotional Products, LLC ("Vantage") granted a security interest in the United States trademark listed on Exhibit A attached hereto (the "Collateral") to Partnership Capital Growth - AFI Fund I, L.P. as Agent (hereinafter referred to as the "Secured Party"), in order to secure repayment of certain amounts then owing to the Secured Party (herein called the "Indebtedness").
