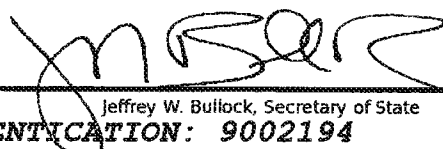

**CERTIFICATE OF MERGER
OF
SALIENT SURGICAL TECHNOLOGIES, INC.
(A DELAWARE CORPORATION)
AND
MARINER MERGER CORP.
(A DELAWARE CORPORATION)**

Pursuant to the provisions of Section 251 of the Delaware General Corporation Law (the "DGCL"), Salient Surgical Technologies, Inc. certifies as follows:

FIRST: The constituent corporations to the merger are:

- (a) Salient Surgical Technologies, Inc., a Delaware corporation; and
- (b) Mariner Merger Corp., a Delaware corporation.

SECOND: An Agreement and Plan of Merger, dated July 6, 2011, was approved, adopted, executed and acknowledged by each of Salient Surgical Technologies, Inc. and Mariner Merger Corp. in accordance with the provisions of Section 251 of the DGCL.

THIRD: The name of the surviving corporation is Salient Surgical Technologies, Inc. (the "Surviving Corporation"). The name of the Surviving Corporation shall be amended in the merger to be "Medtronic Salient Surgical Technologies, Inc."

FOURTH: The merger shall be effective at the time this Certificate of Merger is filed with the Delaware Secretary of State.

FIFTH: The Amended and Restated Certificate of Incorporation attached hereto as Exhibit A shall be the Certificate of Incorporation of the Surviving Corporation as of the effective date of the merger.


SIXTH: The Board of Directors of Mariner Merger Corp. shall be the Board of Directors of the Surviving Corporation as of the effective time of the merger.

SEVENTH: An executed copy of the Agreement and Plan of Merger is on file at the offices of the Surviving Corporation, the address of which is c/o Medtronic, Inc., 710 Medtronic Parkway, Minneapolis, Minnesota 55432 and shall be furnished by the Surviving Corporation, on request and without cost, to any stockholder of any constituent corporation.
