SECOND: The Company was initially incorporated in the State of Delaware on August 5, 1999.

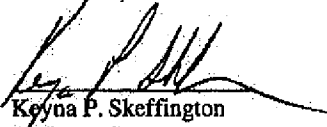

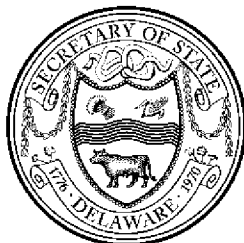

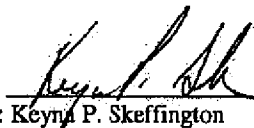
