

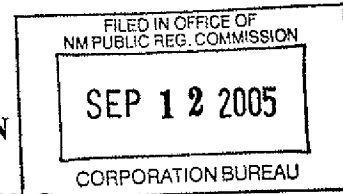

ARTICLES OF ORGANIZATION
OF

The undersigned, acting as organizer of Tinsley Hospitality Group, LLC, under the New Mexico Limited Liability Company Act, adopts the following Articles of Organization:

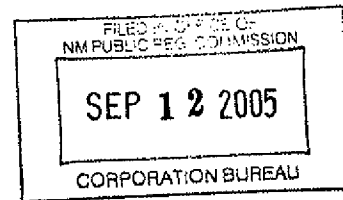
