Assignor represents and warrants that Assignor owns all right, title and interest in and to the Trademarks free of any lien, claim or encumbrances.

Assignor agrees to execute and deliver such additional documents and perform such additional acts as may be reasonably necessary or appropriate to effectuate, carry out, and consummate the terms and conditions of this Assignment and the transactions contemplated thereby.

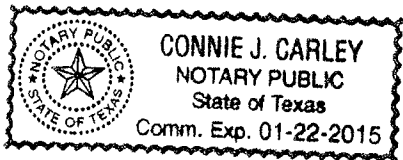
