IN TRADEMARK RIGHTS**

TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS (“Agreement”) dated as of December 20, 2011, from JPMorgan Chase Bank, N.A., as Administrative Agent (the “Agent”) to Six Flags Theme Parks Inc., Funtime, Inc. and Fiesta Texas, Inc.

WITNESSETH:

WHEREAS, pursuant to the First Lien Guarantee and Collateral Agreement, dated as of April 30, 2010 (as amended, supplemented, restated or otherwise modified prior to the date hereof, the “Security Agreement”), made by the Grantors (as defined in the Security Agreement) and certain other subsidiaries of Six Flags Operations Inc. identified therein in favor of the Agent, a security interest (the “Security Interest”) was granted by the Grantors to the Agent in certain collateral, including the Trademark Collateral (as hereinafter defined);

WHEREAS, a Grant of First Lien Security Interest in Trademark Rights agreement evidencing the Security Interest was executed by each Grantor on April 30, 2010 and was recorded in the Trademark Division of the United States Patent and Trademark Office on June 10, 2010, at Reel 4222 and Frame 0210; Reel 4222 and Frame 0250; and at Reel 4222 and Frame 0267; and


WHEREAS, the Agent now desires to terminate and release the entirety of its Security Interest in the Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration including the satisfaction of all obligations, indebtedness and liabilities secured by the Trademark Collateral pursuant to the Security Agreement and the Grant of First Lien Security Interest in Trademark Rights, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Agreement, the Agent hereby states as follows:

1. Definitions. The term “Trademark Collateral”, as used herein, shall mean, with respect to each Grantor, all of such Grantor’s right, title and interest of every kind and nature as of the date hereof in the trademark registrations and applications listed on Schedule A hereto.
2. Release of Security Interest. The Agent hereby terminates, releases and discharges its Security Interest in the Trademark Collateral of each Grantor, and any right, title or interest of the Agent in such Trademark Collateral shall hereby cease and become void.
3. Further Assurances. The Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as reasonably requested by each Grantor to effect the release of the Security Interest contemplated hereby.
