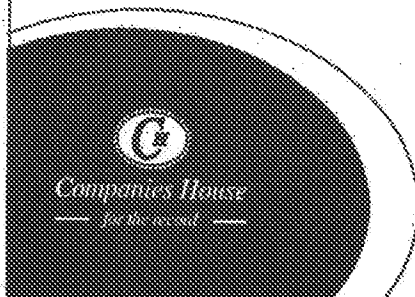
The Registrar further certifies that on the same 15th July 2010 the said company re-registered under the Companies Act 2006 as a private company.
