TRADEMARK RELEASE

THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of December ~~23~~, 2011 by **GENERAL ELECTRIC CAPITAL CORPORATION**, a Delaware corporation, as Agent (“**Agent**”).

WITNESSETH:

WHEREAS, Agent and **INNOWARE PAPER, INC.**, a Connecticut corporation (“**Grantor**”), were parties to that certain Trademark Security Agreement dated as of April 1, 2011 (the “**Agreement**”), pursuant to which Grantor granted a security interest to Agent in certain trademarks (the “**Trademarks**”) and Trademark Collateral (as defined below) as security for certain obligations owing by Grantor to Agent, including the Trademarks set forth on Schedule 1 hereto; and

WHEREAS, the Agreement was recorded by the United States Patent and Trademark Office on April 1, 2011 at Reel 4513 Frame 0588; and

WHEREAS, Grantor has requested that Agent release its security interest in and lien on the Trademarks and Trademark Collateral and reassign the same to Grantor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Agent hereby releases and discharges fully its security interest in and lien on all of Grantor’s right, title and interest in and to the following (collectively, the “**Trademark Collateral**”):

(i) each Trademark, Trademark registration and Trademark application on Schedule 1 attached hereto and each Trademark license;

(ii) all reissues, continuations or extensions of the foregoing;

(iii) all goodwill of the business connected with the use of, and symbolized by, each Trademark and each Trademark license; and

(iv) all products and proceeds of the foregoing, including without limitation, any claim by Grantor against third parties for past, present or future (a) infringement or dilution of any Trademark, Trademark registration or Trademark licensed under any Trademark license or (b) injury to the goodwill associated with any Trademark, Trademark registration or any Trademark licensed under any Trademark license.

2. Agent hereby releases its security interest in and lien on the Trademark Collateral.

3. Agent hereby reassigns, grants and conveys to Grantor, without any representation, recourse or undertaking by Agent, all of Agent's right, title and interest in and to the Trademark Collateral.
