Pursuant to Section 252 of the Delaware General Corporation Law, (the "DGCL"), the undersigned hereby certifies that on December 31, 2007, the board of Directors of IWI, Inc. duly adopted the resolutions attached hereto as Exhibit A that approved the merger of Independent Witness, Inc., a Utah corporation, with and into IWI, Inc., a Delaware corporation, and further certifies as follows:

1. The constituent corporations are: Independent Witness, Inc., a Utah corporation, and IWI, Inc., a Delaware corporation.
2. Independent Witness, Inc. is a wholly-owned subsidiary of Inovar, Inc., a Delaware corporation, and IWI, Inc. is a wholly-owned subsidiary of inthinc, inc., a Delaware corporation.
3. The authorized capital stock of Independent Witness, Inc. is 1,000 shares, consisting of 1,000 shares of Common Stock, \$0.01 par value per share.
4. The merger has been adopted, approved, certified, executed and acknowledged by IWI, Inc., in accordance with the DGCL.
5. The merger has been adopted, approved, certified, executed and acknowledged by Independent Witness, Inc. in accordance with the Utah Revised Business Corporation Act and proper notice has been given pursuant to such act.
6. The Agreement and Plan of Merger, attached hereto as Exhibit A, has been approved, adopted, certified, executed and acknowledged by each of the constituent corporations.
7. The surviving corporation shall be IWI, Inc. and its certificate of incorporation shall continue as the certificate of incorporation.
8. The Merger shall become effective on January 1, 2008.


