TRADEMARK SECURITY AGREEMENT

THIS TRADEMARK SECURITY AGREEMENT (this "Agreement"), is made as of December 19, 2011 by and among Interactive Network, Inc., a Nevada corporation, ("INI"), FriendFinder Networks Inc., a Nevada corporation ("FFN," and together with INI, the "Issuers"), and each Subsidiary of FFN (other than INI) listed on the signature pages hereto (the "Guarantors" and together with the Issuers, the "Grantors") and U.S. Bank National Association, a national banking association, as collateral agent (in its capacity as the "Non-Cash Pay Second Lien Collateral Agent" (as defined in the Cash Pay Second Lien Indenture (as defined below)) and in its capacity as the "Cash Pay Second Lien Collateral Agent" (as defined in the Non-Cash Pay Second Lien Indenture (as defined below)), and together in such capacities, (the "Collateral Agent") for the benefit of (a) the holders of the Non-Cash Pay Second Lien Securities (the "Non-Cash Pay Second Lien Holders") to be issued pursuant to that certain Indenture (as amended and in effect from time to time, the "Non-Cash Pay Second Lien Indenture") dated as of the date hereof, by and among the Issuers, the Guarantors party thereto and U.S. Bank National Association, as trustee (in such capacity, together with its successors in such capacity, the "Non-Cash Pay Second Lien Trustee") and (b) the holders of the Cash Pay Second Lien Securities (the "Cash Pay Second Lien Holders," and together with the Non-Cash Pay Second Lien Holders, the "Holder") to be issued pursuant to that certain Indenture (as amended and in effect from time to time, the "Cash Pay Second Lien Indenture," together with the Non-Cash Pay Second Lien Indenture, the "Indenture") dated as of the date hereof, by and among the Issuers, the Guarantors party thereto and U.S. Bank National Association, as trustee (in such capacity, together with its successors in such capacity, the "Cash Pay Second Lien Trustee," and together with the Non-Cash Pay Second Lien Trustee, the "Trustee").

WHEREAS, pursuant to (a) that certain Cash Pay Second Lien Indenture, the Cash Pay Second Lien Holders have agreed to purchase the Issuers' Cash Pay Secured Notes due 2013 in the initial aggregate principal amount of _____ (the "Cash Pay Second Lien Securities") and (b) that certain Non-Cash Pay Second Lien Indenture, the Non-Cash Pay Second Lien Holders have agreed to purchase the Issuers' Non-Cash Pay Secured Notes due 2014 in the initial aggregate principal amount of _____ (the "Non-Cash Pay Second Lien Securities," together with the Cash Pay Second Lien Securities, the "Securities");

WHEREAS, pursuant to the Indenture, each of the Subsidiary Grantors has guaranteed the obligations of the Issuers in respect of the Indenture, the Securities and the other Note Documents;

WHEREAS, pursuant to the Indenture each Grantor has granted to the Collateral Agent, for the Collateral Agent's benefit and for the benefit of the Trustee, the Holders and U.S. Bank National Association, as collateral agent under the Cash Pay Second Lien Indenture, a security interest in certain assets of such Grantor, including all right, title and interest of such Grantor in, to and under all now owned and hereafter acquired Trademarks (as defined in the Second Lien Security and Pledge Agreement dated as of October 27, 2010 by and between the Issuers, the Subsidiary Grantors and the Collateral Agent (the "Security and Pledge Agreement")) and Trademark Licenses (as defined in the Security and Pledge Agreement), to secure such Grantor's obligations under the Indenture and, in the case of the Issuers, the Notes; and

WHEREAS, each Grantor owns the Trademarks listed beneath such Grantor's name on Schedule I annexed hereto;

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, each Grantor does hereby grant to the Collateral Agent, for the Collateral Agent's benefit and for the benefit of the Trustee and for the ratable benefit of the Holders, a continuing security interest in all of such Grantor's right, title and interest in, to and under the following, in each case whether presently existing or hereafter created or acquired (all of the following items or types of property being herein collectively referred to as the "Trademark Collateral"), to secure the Obligations of such Grantor:

- (1) each Trademark referred to in the Schedule I annexed; and
- (2) each Trademark License.


