GRANT OF SECURITY INTEREST (TRADEMARKS)

The undersigned, **BCC RESEARCH, LLC**, a North Carolina limited liability company (the "**Grantor**"), and **CAPITAL ONE, NATIONAL ASSOCIATION**, (the "**Lender**") are parties to a Security Agreement, dated as of the date hereof (as amended, supplemented or otherwise modified from time to time, the "**Security Agreement**").
