**TERMINATION AND RELEASE OF
SECURITY AGREEMENT**

This TERMINATION AND RELEASE OF SECURITY AGREEMENT (the "Release") is entered into by and between MULLINIX PACKAGES, INC., an Indiana corporation (the "Pledgor") and BANK OF AMERICA, N.A., a national banking association (the "Bank").

WHEREAS, the Pledgor executed a certain Security Agreement in favor of the Bank, dated June 26, 2009, reflecting the security interest in and to the described trademarks and the related goodwill granted by the Pledgor to the Bank. NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Bank hereby terminates and releases its security interest in and lien on the trademarks and the related goodwill of the Pledgor held pursuant to the above-referenced Security Agreement, including but not limited to those certain trademarks listed on Schedule A attached to and made a part of this Release, and the Bank hereby terminates the Security Agreement.

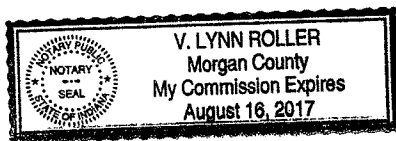
