TRADEMARK AND COPYRIGHT ASSIGNMENT

WHEREAS, SSI IP HOLDINGS, LLC, a limited liability company organized and existing under the laws of the State of Delaware with a place of business in Radnor, Pennsylvania (“Assignee”), wishes to acquire (i) any and all rights in and to the Marks, together with the goodwill of the business appurtenant to and symbolized by the Marks, along with the right to recover for damages and profits for past infringements thereof, and (ii) any all rights in and to the Work, along with the right to recover for damages and profits for past infringements thereof;


NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, and intending to be legally bound hereby, Assignor does hereby sell, assign and transfer to Assignee (i) all right, title and interest in and to the Marks, together with the goodwill of the business appurtenant to and symbolized by the Marks, along with the right to recover for damages and profits for past infringements thereof, as well as (ii) all right, title and interest in and to the Work, along with the right to recover for damages and profits for past infringements thereof.

Assignor agrees to execute and deliver, at the request of the Assignee, all papers, instruments and assignments, and to perform any other reasonable acts the Assignee may require in order to vest all Assignor’s right, title and interest in and to the Marks and the Work in Assignee and/or to provide evidence to support any of the foregoing in the event such evidence is deemed necessary by Assignee, to the extent that such evidence is in the possession or control of Assignor.
