**RATIFICATION OF ASSET AND STOCK PURCHASE AGREEMENT AND
NUNC PRO TUNC ASSIGNMENT**

WHEREAS, Washington Free Weekly, Inc., a Delaware corporation, (hereinafter "Registrant") is registrant of U.S. Registration No. 3,170,772 for the service mark CRAFTY BASTARDS filed on April 29, 2005, and registered on November 14, 2006 (hereinafter the "Service Mark");

WHEREAS, on July 23, 2007, Registrant and Chicago Reader, Incorporated did agree to assign all right, title and interest in the Service Mark to CL Chicago, Inc., a Florida corporation and a wholly owned subsidiary of Creative Loafing, Inc., and CL Washington, Inc., a Florida corporation and a wholly owned subsidiary of Creative Loafing, Inc. as set forth in an Asset and Stock Purchase Agreement and in consideration of the payment of a certain amount disclosed in the Asset and Stock Purchase Agreement and other good and valuable consideration;

WHEREAS, on July 24, 2007, an assignment was executed and on August 8, 2007, said assignment was filed with the United States Patent and Trademark Office assigning the Service Mark from Chicago Reader, Inc. to CL Chicago, Inc., a Florida corporation, assigning all right, title and interest in and to the Service Mark;

WHEREAS, Registrant and CL Chicago, Inc. wish to confirm and ratify the Asset and Stock Purchase Agreement wherein the Service Mark and all of rights, title and interest thereto were sold to CL Chicago, Inc. and CL Washington, Inc.;

WHEREAS, Registrant and CL Chicago, Inc. wish to confirm and ratify the assignment from Registrant to CL Washington, Inc. of the Service Mark **NUNC PRO TUNC** as of July 24, 2007;

NOW, THEREFORE, CL Chicago, Inc. does hereby sell, transfer, assign and deliver unto CL Washington, Inc., all right, title and interest in and to the Service Mark together with the goodwill of the business connected with and symbolized by the Service Mark, as well as the right to bring any and all claims for infringement of said Service Mark which claims arose, or are in any way based on acts that occurred, prior to the date of this assignment and all rights to damages or profits, due or accrued, arising out of infringement of such Service Mark or injury to said goodwill occurring after the date hereof and the right to sue for and receive the same in the CL Washington, Inc.'s own name.
