DECLARATION OF JOSEPH J. JANICZEK

I, Joseph J. Janiczek, declare and state as follows:

1. I am Chairman of Wealth with Ease, LLC (formerly Living Richer Longer, LLC), a Delaware limited liability company with a business address at 8400 E. Crescent Parkway, Suite 160, Greenwood Village, Colorado 80111.

2. I am also the sole owner of Prosperity Press, LLC, a Colorado limited liability company, with a business address at 8400 E. Crescent Parkway, Suite 160, Greenwood Village, Colorado 80111.

3. I have personal knowledge of the facts set forth in this declaration, and could testify competently thereto if called upon to do so.

4. THE SEEDS OF FINANCIAL FREEDOM mark Registration No. 2526047, WITH EASE mark Registration No. 2754258, WEALTH WITH EASE mark Registration No. 2811503, THE STAGES OF FINANCIAL FREEDOM FOUNDATION STAGE GROWTH STAGE TRANSITION STAGE SECURITY STAGE DISTRIBUTION STAGE RUNAWAY GROWTH GROWTH MAINTENANCE CONTROLLED DEPLETION UNCONTROLLED DEPLETION PEAK GROWTH EARTY GROWTH NETWORTH TIME (&Design) Registration No. 2693731, THE STAGES OF FINANCIAL FREEDOM mark Registration No. 2589373, and THE HABITS OF FINANCIAL FREEDOM mark Registration No. 2532933 were registered with the U.S. Patent and Trademark Office ("USPTO") in the name of Prosperity Press, LLC respectively on January 1, 2002; August 19, 2003; February 3, 2004; March 4, 2003; July 2, 2002; and January 22, 2002.

On June 1, 2006, Prosperity Press, LLC assigned all its rights, interests in and title to THE SEEDS OF FINANCIAL FREEDOM mark Registration No. 2526047, WITH EASE mark Registration No. 2754258, WEALTH WITH EASE mark Registration No. 2811503, THE STAGES OF FINANCIAL FREEDOM FOUNDATION STAGE GROWTH STAGE TRANSITION STAGE SECURITY STAGE DISTRIBUTION STAGE RUNAWAY GROWTH GROWTH MAINTENANCE CONTROLLED DEPLETION UNCONTROLLED DEPLETION PEAK GROWTH EARTY GROWTH NETWORTH TIME (&Design) Registration No. 2693731, THE STAGES OF FINANCIAL FREEDOM mark Registration No. 2589373, and THE HABITS OF FINANCIAL FREEDOM mark Registration No. 2532933 in the United States and other countries and jurisdictions, together with the goodwill associated with the marks, to Living Richer Longer, LLC, as described above a Delaware limited liability company

6. On February 23, 2010, Living Richer Longer, LLC changed its name to Wealth with Ease, LLC. The address of the company remains to be same.

7. On October 31, 2007, with regard to Registration Nos. 2532933; 2526047; and 2589373, it was mistakenly recorded at the USPTO with Reel/Frame No. 3651/0475 that Prosperity Press, LLC changed its name on August 24, 2007 to Living Richer Longer LLC, a Colorado limited liability company. It needs to be corrected to reflect that the conveyance was not a name change but an assignment, and the assignee's citizenship is Delaware and not Colorado. Furthermore, the date of the assignment was June 1, 2006. The conveyance affecting the ownership of the mark, its date, and the conveyee's citizenship were submitted wrong in Reel/Frame 3651/0475 due to an inadvertent mistake.

8. On January 23, 2009, with regard to Registration No. 2693731, it was mistakenly recorded at the USPTO with Reel/Frame No. 3924/0897 that Prosperity Press, LLC changed its name on January 22, 2009 to Living Richer Longer LLC, a {00567686v1}

Colorado limited liability company. It needs to be corrected to reflect that the conveyance was not a name change but an assignment, and the assignee's citizenship is Delaware and not Colorado. Furthermore, the date of the assignment was June 1, 2006. The conveyance affecting the ownership of the mark, its date, and the conveyee's citizenship were submitted wrong in Reel/Frame 3924/0897 due to an inadvertent mistake.



On April 24, 2009, with regard to Registration Nos. 2811503 and 2754258 with Reel/Frame No. 3976/0618, it was mistakenly recorded at the USPTO that Prosperity Press, LLC changed its name on March 25, 2009 to Living Richer Longer LLC (TA Living Richer Longer, LLC), a Colorado limited liability company. It needs to be corrected to reflect that the conveyance was not a name change but an assignment, and the assignee's citizenship is Delaware and not Colorado. Furthermore, the date of the assignment was June 1, 2006. Furthermore, the assignee's name should be corrected to reflect its official company name with company designation "LLC": Living Richer Longer, LLC and the "TA Living Richer Longer LLC" should be removed. The conveyance affecting the ownership of the mark, its date, and the conveyee's full name and citizenship were submitted wrong in Reel/Frame 3976/0618 due to an inadvertent mistake.
