TRADEMARK ASSIGNMENT

This Assignment is made effective this December 31, 2011, by ICT Resources, Inc., a Delaware corporation, having its sole office address at 300 Delaware Avenue, Suite 1224, Wilmington, Delaware 19801, in favor of ICT Enterprises, Inc., a Delaware corporation, having its sole office address at 300 Delaware Avenue, Suite 1224, Wilmington, Delaware 19801.

WHEREAS ICT Resources, Inc. has adopted and used, and, through a related party license agreement, continues to use those Trademarks, trade names and service marks identified on the attached Schedule A, which are registered with the US Patent and Trademark Office to the extent noted on Schedule A (hereinafter referred to as the "Trademarks").

WHEREAS: ICT Resources, Inc. and ICT Enterprises, Inc. have entered into a **Plan of Complete Liquidation** pursuant to which ICT Resources, Inc. will be dissolved and liquidated, and all of ICT Resources, Inc.'s remaining assets, including the Trademarks, shall be assigned to ICT Enterprises, Inc. in exchange for the complete surrender and cancellation of the capital stock of ICT Resources, Inc. held by ICT Enterprises, Inc. at the time of the liquidation (hereinafter, the "Liquidation").


AND WHEREAS: it is desired that the assignment of said Trademarks contemplated by the **Plan of Complete Liquidation** be made of record in the United States Patent and Trademarks Office.

NOW, THEREFORE, pursuant to the **Plan of Complete Liquidation**, and, for good and valuable consideration, receipt of which is hereby acknowledged, ICT Resources, Inc. does hereby assign and transfer unto said ICT Enterprises, Inc., and for ICT Enterprises, Inc.'s successors and assigns, all right, title and interest in and to said Trademarks, together with the goodwill of the business symbolized by said Trademarks, and the registrations thereof; and for aforesaid considerations ICT Resources, Inc. hereby covenants, agrees and undertakes to execute whenever requested by ICT Enterprises, Inc., all applications, assignments, lawful oaths and any other documents that ICT Enterprises, Inc. may reasonably deem necessary or desirable for securing to ICT Enterprises, Inc., or for maintaining for ICT Enterprises, Inc., the Trademarks hereby assigned or agreed to be assigned; all without further compensation to ICT Resources, Inc.
