**TERMINATION AND RELEASE OF
SECURITY INTEREST IN TRADEMARKS**

WHEREAS **Emtec, Inc.**, a New Jersey corporation (the "Grantor"), entered into that certain security agreement dated August 15, 2011 (the "Security Agreement") with **De Lage Landen Financial Services, Inc.** ("DLL"), a Michigan corporation, notice of which was recorded August 17, 2011 at the United States Patent and Trademark Office at Reel 4606, Frame 0380.


WHEREAS, Grantor granted DLL, under the terms of the Security Agreement, a security interest (the "Security Interest") in favor of DLL in and to certain of Grantor's intellectual property, including without limitation the trademark registrations listed in **Schedule A**, (the "Trademarks") and all of the goodwill of the business connected with the use of, and symbolized by the Trademarks.

WHEREAS, DLL has agreed to terminate and release its security interest in all such Trademarks.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, DLL hereby releases the Security Interest, hereby waives and relinquishes all its rights, powers, privileges and remedies with respect to Grantor and its successors and assigns in association with the Security Interest, and hereby releases Grantor and its successors and assigns from all covenants, obligations, liabilities and warranties in association with the Security Interest.
