## GENERAL INTELLECTUAL PROPERTY ASSIGNMENT DEED

THIS AGREEMENT made effective as of December 31, 2011 ("Effective Date")

BETWEEN:

**MR Holdings (HK) Limited**, a company organized under the laws of Hong Kong, with offices at 1 Harbor Road, Units 13-14, 28th Floor, Convention Plaza Office Tower, Hong Kong (hereinafter: "the Assignor");

AND

**MR Investments (HK) Limited**, a company organized under the laws of Hong Kong, with offices at 1 Harbor Road, Units 13-14, 28th Floor, Convention Plaza Office Tower, Hong Kong (hereinafter: "the Assignee");

WHEREAS:

- (A) The Assignor wishes to assign to the Assignee all of the right, title and interest it owns in the Intellectual Property (defined below); and
- (B) The Assignee wishes to take an Assignment of all right, title and interest in and to the Intellectual Property in all jurisdictions of the world;

NOW IT IS HEREBY AGREED AS FOLLOWS:

### 1. DEFINITIONS:

"Intellectual Property" shall include all trademarks, service marks and names that Assignor acquired from Datascope Trademark Corporation and/or Datascope Corporation from March 1, 2008 through and including the Effective Date, including, without limitation, the ACCUTORR, ANESTAR, FLEXISENSOR, MULTINEX, PANORAMA, PASSORT, SENSOR GUARD and SPECTRUM trademarks and the registrations and applications listed in Appendix A hereto, and all variants, formatives, foreign-language translations, transliterations and versions, and acronyms of each of the foregoing.

### 2. ASSIGNMENT:

- 2.1. In exchange for good and valuable consideration, the receipt of which is hereby acknowledged, Assignor hereby assigns, conveys and transfers to Assignee all of its worldwide rights, title and interest in the Intellectual Property whether based upon statute, civil code, or common law or use rights or based upon any applications or registrations whether granted, pending, suspended or abandoned, together with the


goodwill of the business associated therewith, and the right to sue for past, present and future infringements and the right to retain any damages as a result of any such action;

3. FURTHER ASSURANCE:


3.1. The Assignor undertakes, at the request of Assignee, to execute any confirmatory trademark assignments or other documents that may be required subsequent to the signing of this General Intellectual Property Assignment Deed in order to record the transfer of ownership of the Intellectual Property in the individual jurisdictions, including any trademark registrations or applications set out in Appendix A attached hereto, to the Assignee and its successors, assigns and nominees.
