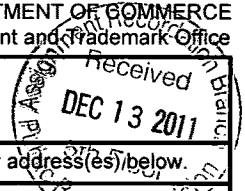

ASSIGNMENT OF TRADEMARKS

Background

This Assignment of Trademarks is entered into this 17th day of Nov., 2011 (the "Assignment") by and between E-Brands Restaurants, LLC, having a business address of 9350 Conroy Windermere Road, Windermere Florida 34786 (hereinafter referred to as "Assignor") and Kevin Enderle, of 4022 McIntosh Road, Dover, Florida 33527 (hereinafter referred to as "Assignee").

WHEREAS, Assignor has used and is using, and is the owner of the entire right, title, and interest in the trademarks SAMBA ROOM and design, Registration Number 3,625,771, registered May 26, 2009; SAMBA ROOM, Registration Number 2,811,996, registered February 10, 2004; and SAMBA ROOM A CUBAN BAR AND LATIN CAFE, Registration Number 2,601,386, registered July 30, 2002 ("Trademarks"); and

WHEREAS, Assignee wishes to purchase the entire right, title, and interest in and to the Trademarks, including the goodwill of the business symbolized by the Trademarks, from the Assignor.

NOW THEREFORE, in consideration of the foregoing recitals, and the mutual promises and conditions set forth herein, the parties agree as follows:

Terms

In consideration of the premises stated herein and the payment of Fifteen Thousand Dollars (\$15,000.00), the receipt and sufficiency of which is hereby expressly acknowledged, Assignor hereby assigns, transfers, conveys, and sets over unto Assignee, his successors, assigns and legal representatives, the entire right, title, and interest in and to the Trademarks, free of any encumbrances, together with the goodwill of the business represented thereby, in connection with which the Trademarks were and are used and all rights incident thereto. Assignee shall also, on the execution date of this Assignment, reimburse Assignor for its reasonable attorneys' fees incurred in connection with this Assignment.

Assignor hereby releases, assigns, and transfers unto Assignee his successors, assigns and legal representatives, all rights, title, and interest, claims and demands whatsoever Assignor had in, to and by, under and through, the Trademarks, including all claims for any and all past infringement thereof and the right to sue therefor.

Furthermore, Assignee agrees that in the event Assignee transfers the Trademarks for value to a third party at any time up to eighteen (18) months from the date of execution of this Assignment, then Assignee shall pay Assignor an additional amount equal to fifty percent (50%) of the purchase price paid to Assignee by the third party, within ten (10) days of said third-party transfer. This Assignment of Trademarks is made subject to this limitation.

The Trademarks are to be held and enjoyed by Assignee for his own use and profit and for his successors, assigns and legal representatives as fully and entirely as the same would have been held and enjoyed by said Assignor had this assignment not been made.



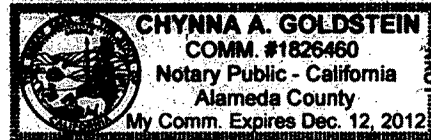

INSTRUCTIONS FOR COMPLETING THIS FORM
