DECLARATION OF JOSEPH J. JANICZEK

I, Joseph J. Janiczek, declare and state as follows:

1. I am the Chairman of Wealth with Ease, LLC (formerly Living Richer Longer LLC), a Delaware limited liability company with a business address at 8400 E. Crescent Parkway, Suite 160, Greenwood Village, Colorado 80111.
2. I am also the sole owner of Prosperity Press, LLC, a Colorado limited liability company, with a business address at 8400 E. Crescent Parkway, Suite 160, Greenwood Village, Colorado 80111.
3. I had been the sole owner and Manager of ABSOLUTEFINANCIALFREEDOM.COM, LLC, a Colorado limited liability company, with a business address 6093 S. Emporia Court, Englewood, Colorado 80111 from its formation to its dissolution.
4. I am the Chief Executive Officer of Janiczek & Company, Ltd. a Colorado corporation with a business address at 8400 E. Crescent Parkway Suite 160, Greenwood Village, Colorado 80111.
5. I have personal knowledge of the facts set forth in this declaration, and could testify competently thereto if called upon to do so.
6. ABSOLUTE FINANCIAL FREEDOM mark was applied to register with the U.S. Patent and Trademark Office ("USPTO") by Prosperity Press, LLC with Serial No. 76004140 on March 20, 2000 and was assigned to ABSOLUTEFINANCIALFREEDOM.COM, LLC on March 20, 2001. Accordingly, the ABSOLUTE FINANCIAL FREEDOM mark was registered in the name of

ABSOLUTEFINANCIALFREEDOM.COM, LLC with Registration No. 2541511 on February 19, 2002.

7. On information and belief, due to the USPTO's clerical error the certificate of registration for the ABSOLUTE FINANCIAL FREEDOM mark read the name of the registrant as ABSOLUTEFINANCIAL FREEDOM.COM, LLC, which I recently have become aware of.

8. ABSOLUTEFINANCIALFREEDOM.COM (& Design) and NEVER WORRY ABOUT MONEY AGAIN! marks were also registered with the USPTO in the name of ABSOLUTEFINANCIALFREEDOM.COM, LLC respectively on July 29, 2003 with Registration No. 2742793 and on November 12, 2002 with Registration No. 2650257.

9. On October 1, 2004, ABSOLUTEFINANCIALFREEDOM.COM, LLC assigned all its rights, interests in and title to the ABSOLUTE FINANCIAL FREEDOM trademark and Registration No. 2541511, ABSOLUTEFINANCIALFREEDOM.COM (& Design) trademark and Registration No. 2742793, and NEVER WORRY ABOUT MONEY AGAIN! trademark and Registration No. 2650257 in the United States and other countries and jurisdictions, together with the goodwill associated with the marks, to Janiczek & Company, Ltd.

10. On June 1, 2006, Janiczek & Company, Ltd. assigned all its rights, interests in and title to the ABSOLUTE FINANCIAL FREEDOM trademark and Registration No. 2541511, ABSOLUTEFINANCIALFREEDOM.COM (& Design) trademark and Registration No. 2742793, and NEVER WORRY ABOUT MONEY AGAIN! trademark and Registration No. 2650257 in the United States and other countries and jurisdictions, together with the goodwill associated with the marks, to Living Richer Longer, LLC, a Delaware limited liability company with a business address at 8400 E. Crescent Parkway, Suite 160, Greenwood Village, Colorado 80111.

11. On February 23, 2010, Living Richer Longer, LLC changed its name to Wealth with Ease, LLC. The address of the company remains to be same.

On May 27, 2009, with regard to ABSOLUTEFINANCIALFREEDOM.COM (&Design) Registration No. 2742793 it was mistakenly recorded at the USPTO with Reel No. 3993 and Frame No. 0668 that ABSOLUTEFINANCIALFREEDOM.COM, LLC changed its name on May 27, 2009 to Living Richer Longer LLC, a Colorado limited liability company. It needs to be corrected to reflect that at the time of the recordation of Reel/Frame 3993/0668 the owner of the mark was Janiczek & Company, Ltd and the conveyance was in the nature of assignment of the mark from Janiczek & Company, Ltd to Living Richer Longer, LLC, a Delaware limited liability company effective June 1, 2006. The conveyance affecting the ownership of the mark, the conveyance date, the conveyor's identity and conveyee's citizenship were submitted wrong in Reel/Frame 3993/0668 due to an inadvertent mistake.


