**ARTICLES OF INCORPORATION
WITH STATEMENT OF CONVERSION**

OF

METHODICS INC.

The undersigned, pursuant to General Corporation Law of the State of California, states as follows:

I

The name of this corporation is Methodics Inc.

II

The purpose of the corporation is to engage in any lawful act or activity for which a corporation may be organized under the General Corporation Law of California other than the banking business, the trust company business or the practice of a profession permitted to be incorporated by the California Corporations Code.

III

IV

This corporation is authorized to issue only one class of stock, and the total number of shares that this corporation is authorized to issue is 10,000,000.

V

The name of the converting California limited liability company is Methodics LLC. The limited liability company's California Secretary of State file number is 200615310070. The principal terms of the plan of conversion were approved by a vote of the members, which equaled or exceeded the vote required under Section 17540.3. There is one class of members entitled to vote and the percentage vote required is a majority in interest of the members. The limited liability company is converting to a California stock corporation.

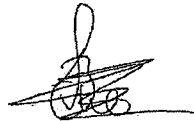

Any repeal or modification of this Article, or the adoption or any provision of the Articles of Incorporation inconsistent with this Article, shall only be prospective and shall not adversely affect the rights under this Article in effect at the time of the alleged occurrence of any act or omission to act giving rise to liability.

This corporation is authorized to provide indemnification of agents (as defined in Section 317 of the California Corporations Code) through bylaw provisions, agreements with agents, vote of shareholders or disinterested directors or otherwise, in excess of the indemnification otherwise permitted by Section 317 of the California Corporations Code, subject only to the applicable limits set forth in Section 204 of the California Corporations Code with respect to actions for breach of duty to this corporation and its shareholders. Any repeal or modification of this Article, or the adoption of any provision of the Articles of Incorporation inconsistent with this Article, shall only be prospective and shall not adversely affect the rights under this Article in effect at the time of the alleged occurrence of any action or omission to act giving rise to indemnification.
