NUNC PRO TUNC ASSIGNMENT

WHEREAS, Bella Restaurant, Inc., a Texas corporation ("ASSIGNOR"), having its principal offices at 320 Main Street, Houston, Texas 77002, is the owner of United States Trademark Registration No. 3,565,512 for MIA BELLA TRATTORIA (the "TRADEMARK");

WHEREAS, MiaBellaFranchise, L.L.C., a Texas limited liability company ("ASSIGNEE"), having its principal offices at 2006 Lexington, Houston, Texas 77098, is desirous of acquiring all rights, title, and interest in and to said Trademark;

WHEREAS, Assignor and Assignee would now like to document a previous oral agreement with a written assignment;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby sells, assigns, transfers, conveys and delivers to Assignee, its successors and assigns, all of Assignor's entire rights, title, and interest in and to said Trademark together with all common law rights, rights of priority, and goodwill of the business symbolized by Assignor's said Trademark, and furthermore all rights and causes of action (including damages recoverable thereby) for past, present, and future unauthorized use of the Trademark, including but not limited to all rights and causes of action for infringement and unfair competition of said Trademark.

The rights conveyed by this Assignment shall be effective *nunc pro tunc* on October 5, 2009.

Assignor further covenants and agrees that it and its representatives will, at Assignee's request and expense, do all other lawful acts necessary to enable Assignee to obtain, maintain and fully enforce the benefit of the rights, title and interest, assigned, transferred, and conveyed. Assignor represents and warrants that it owns all rights, title, and interest in and to the Trademark and that it has the authority to transfer all of the rights, title and interest assigned, transferred, and conveyed pursuant to this Agreement.

IN WITNESS WHEREOF, Assignor and Assignee have caused this Assignment to be executed on the 5th day of October, 2009 and effective by their duly authorized officers or representatives this 22 day of December, 2011.
