NOTICE OF ASSIGNMENT OF SECURITY INTEREST IN TRADEMARKS

THIS NOTICE OF ASSIGNMENT OF SECURITY INTEREST IN TRADEMARKS (this "Assignment"), dated as of December 29, 2011, is by and between GENERAL ELECTRIC CAPITAL CORPORATION, as agent (in such capacity, the "Prior Agent") and GNSD LLC, as successor agent (in such capacity, the "New Agent").

WHEREAS, in connection with the Credit Agreement dated as of September 24, 2004, among National Semi-Trailer Corp. (the "Grantor"), the credit parties signatory thereto, the lenders signatory thereto and Prior Agent, as agent (as amended and restated pursuant to that certain Amended and Restated Credit Agreement dated as of September 28, 2007 and as further amended and restated, amended, supplemented, or otherwise modified from time to time, the "Credit Agreement"), Grantor executed the Trademark Security Agreement dated as of September 24, 2004 in favor of Prior Agent (as reaffirmed pursuant to that certain Reaffirmation of Guaranty and Security Documents dated as of September 28, 2007, the "Trademark Security Agreement"), pursuant to which Grantor granted to Prior Agent a security interest in Grantor's trademarks set forth on Schedule A attached hereto (the "Trademarks") and which was recorded by the United States Patent and Trademark Office on October 20, 2004, at Reel 2960, Frame 0421.

WHEREAS, pursuant to that certain Agency Transfer Agreement dated as of December 29, 2011 by and among Borrower, Prior Agent and New Agent, (i) Prior Agent resigned as agent under the Credit Agreement and New Agent was appointed as the successor agent and (ii) Prior Agent assigned all rights, liens and security interests under the Collateral Documents (as defined in the Credit Agreement) (including, without limitation, the Trademark Security Agreement) to New Agent.

WHEREAS, Prior Agent and New Agent wish to provide a document suitable for recording in the United States Patent and Trademark Office for purposes of recording the assignment of its security interest in the Trademarks from Prior Agent to New Agent.

NOW THEREFORE, in consideration of and in exchange for good and valuable consideration, the receipt of which is hereby acknowledged, the Prior Agent hereby assigns to New Agent all of its security interest in the Trademarks.
